What are the biggest issues facing the school district?

I think that we have many of the same issues that are plaguing districts all over Texas. We are facing budget deficits and enrollment declines. Over 40% of our students are emerging bilingual students; we need to make sure that we are offering the resources and support for these students. We are still looking at building reading proficiency and math proficiency after pandemic setbacks. Teacher retention and supporting new teachers, especially those coming with alternative certifications, is also an issue. I think that our district and school board are working very hard on solutions that do not compromise student success. While there are definitely challenges, I believe that we have a district that seeks to solve them.

As a district, we continue to see an influx of students moving in from out of the country, which means specialized support for the students to assimilate into our American public schools. The district is designing and implementing support systems for these students. However, we must continue to focus on academic growth for all students. Every single student in our district deserves the highest quality of services, meeting them where they are poised for growth. Providing teachers and administrators opportunities to have high quality professional development, and time to plan for students using data-based decision making is critical. I think it's important for voters to know that a lot of COVID relief funds were strategically invested in supporting students, however, those funds are ending. Thus, we must continue to design local budgets that are focused

on investing in student needs. I am proud of our board's commitment and focus on accountability for student outcomes. I am also excited about the approved 24-25 school calendar, as it reflects a focus on supporting our teachers with time to plan for students.

Growth academically is critically important to the future of our community but cannot be underscored by a need for a safe and secure learning environment. The district continues to make strategic decisions to support a safe and secure learning environment, while also investing in pro-active support like our counseling services. Supporting the whole child continues to be a need and expectation of our community.
