I also advocated for Medicaid expansion through Rep. Johnson and Sen. Johnson's Live Well Texas bill through SickOfItTexas this last 88th Legislative Session. As someone who lost her father to gun violence, and an Everytown for Gun Safety Fellow, fighting for common-sense gun legislation is personal and something I will never stop advocating for to ensure that not one more family experiences what mine has. That's why I have Rep. Johnson's support for this run and I'm the only candidate in this race supported by law enforcement (National Latino Law Enforcement Association), public school

I started canvassing in September because of the importance of spreading the word about Prop 9 across HD115 (the cost-of-living-adjustment for retired teachers) during the Nov. 2023 Texas Constitutional Amendment Election. To fund these improvements, we must review our spending priorities in the budget and explore new sources of revenue to support public education including the expansion of sports gambling, the legalization and creation of a retail cannabis market, and eliminating loopholes in our state</p>

hundreds of thousands of Texans which I advocated for already in the Legislature. I will make sure to continue to champion the bipartisan Live Well Texas bill in the 89 Legislative Session that Rep. Johnson has fought so hard to pass. Thirdly, public safety – the time is long past for our state government to take real steps in reducing gun violence, and I will advocate for common-sense legislation as someone who lost her father to gun violence and an Everytown for Gun Safety Fellow. I also want to combat the fentanyl crisis that is decimating our district, primarily by legalizing fentanyl test strips, a common-sense measure the Texas Legislature failed to pass in the 88th Legislative Session. But most importantly, I will make sure to stand for local control on all of these matters and more. We must make sure that our duly elected

tax code that benefit corporations at the expense of everyday Texans. The next chapter of Texas education is being written now, and we must ensure that it is defined by fully funded public schools, quality teachers, and no voucher scams.

Second, I want to make sure all Texans are safe from gun violence, especially in our schools. I oppose unfunded mandates like armed security officers. Instead, we need to pass common sense gun safety legislation, and I hope to use my real world experience prosecuting gun crimes to do so. We should eliminate the personal collection loophole and require mandatory background checks and red flag laws. We should raise the age to purchase assault weapons.

local leaders have the ability to make the best decisions for our community and I will continue to stand up to any attempts to dilute Texans' vote to elect whom they want to make decisions.

Finally, my third priority is fighting for our reproductive rights. My mom was a labor and delivery nurse at our Dallas County hospital, Parkland. My family has long been pro-choice, and I have learned from my mother, my experience, and the experiences of countless parents, that the government has no business in the hospital room. What happens should be between a woman and her doctor, not a woman and the government. It is wrong to legislate as if all pregnant women and pregnancy experiences are the same. I support a woman's right to choose. Short of making a constitutional right to abortion here, I would support legislation that further chips away at the blanket ban against abortion, including legislation that exempts rape, incest, and life of the mother, among others. I would clarify that fertility treatments are

		<p>permitted, especially since my daughter exists due to the miracle that is IVF. Finally, I am against travel bans that would criminalize crossing the state border to obtain abortions.</p>
